AUTHORIZING A CONTRACT BETWEEN DANE COUNTY AND CORRECT CARE SOLUTIONS FOR THE PROVISION OF INMATE HEALTH AND MENTAL HEALTH CARE SERVICES

Policy Analysis Statement:

Brief Description of Proposal -
Request approval to award a five-year contract to Correct Care Solutions (CCS) for the provision of health and mental health care services to inmates at the three County detention facilities.

Current Policy or Practice -
Contracts for amounts exceeding \$100,000 require County Board approval.

Impact of Adopting Proposal -
The Sheriff's Office has an ethical, and constitutional obligation to provide necessary medical and mental health treatment and emergency dental care to inmates in custody. Each inmate must be screened at intake for medical, mental health, dental conditions, physical and developmental disabilities, alcohol or other drug abuse problems, and suicide risk. Medical staff is responsible for the provision of routine and urgent medical, mental health and dental care for those incarcerated. This includes conducting a health appraisal, in accordance with protocols established by a responsible physician, within 14 days of the inmate's arrival at the facility. All documentation of medical, mental health and dental information must be kept in each inmate's confidential medical file. In addition, medical staff is responsible for the control, delivery, and administration of prescription and nonprescription medications.
