Hello. I am unable to be with you all tonight, but I wanted to send in a statement. Project Home is a vital resource in Dane County.

As a first time home buyer, there were many projects I had to accomplish over the last few years that were unplanned for that timeline. After two winters dealing with single pane windows, I needed to make an upgrade to preserve the integrity and comfort of my home. I wasn't sure how I was going to afford new windows for a 100 year old house that has almost 30 windows between my first and second floors. I found Project Home after doing some research on possible grants. After a couple conversations with Wyolanda, I knew I had found a partner in this project.
