AUTHORIZING ASSIGNMENT AND AMENDMENT OF LEASE NO. DCRA 2007-06 INVOLVING LAND AT THE DANE COUNTY REGIONAL AIRPORT

### **Policy Analysis Statement:**

#### Brief Description of Proposal -

Blettner Equipment Leasing, LLC has requested Dane County's approval of an assignment of Land Lease No. DCRA 2007-06 to Infinity Turbine LLC. Infinity Turbine LLC is seeking to purchase the building and other improvements on the leasehold.

### Current Policy or Practice -

Under Lease No. DCRA 2007-06, Blettner Equipment Leasing, LLC leases 11,700 square feet of land at the Dane County Regional Airport. Blettner Equipment Leasing, LLC has constructed an aircraft hangar and associated improvements on the leased property.
