ACCEPTING FUNDING FOR FOODSHARE EMPLOYMENT AND TRAINING LOCAL-FED MATCH DCDHS - EAWS DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

The Department of Health Services (DHS) contracts with Dane County Department of Human Services to administer the FoodShare Employment and Training (FSET) Program. As of April 1, 2015, DCDHS was awarded the FoodShare Employment and Training contract for a 6-County region. Due to the expansion of our service area and FoodShare policy changes it is expected the FSET program will increase annual participation from about 700 job-seeking adults to 3,600. To successfully manage the increased workload, DCDHS solicited agencies to create job training and job search programs that would qualify for a federal match of funds. DHS notified us that all programs were approved as part of the FSET contract.

Current Policy or Practice -

Budget and professional service contract changes require County Board approval.

Impact of Adopting Proposal -

This resolution allows DCDHS EAWS Division to contract with the agencies listed the resolution to provide FSET services in Region 10 effective April 1 through September 30, 2015. These contracted programs may continue as long as this funding continues. If a contracted program is evaluated as not meeting program standards, the contract may be terminated early. If DCDHS ceases to operate FSET in Region 10, the contracted programs will no longer receive a federal match.
