AUTHORIZING EXTENDING INTERAGENCY AGREEMENT #MSN200017 BETWEEN THE DANE COUNTY DISTRICT ATTORNEY'S OFFICE AND THE UNIVERSITY OF WISCONSIN POPULATION HEALTH INSTITUTE

Policy Analysis Statement:

Brief Description of Proposal -

A previously negotiated Interagency Agreement Amendment with the Dane County District Attorney's Office and the University of Wisconsin Population Health Institute to technical assistant with the Opiate Diversion Program for Treatment Alternatives and Diversion Project expires on December 31, 2020. An extension of the Interagency Agreement Amendment to Technical Assistant with the Opiate Diversion Program #MSN200017 for Treatment Alternative and Diversion Project Year 5 (2021) Agreement has been negotiated as follow:

Revision: Adjust contract total from current amount of \$120,000 to a total of \$150, 000, a change of \$30,000.

Revision: Change the end date from December 31, 2020 to December 31, 2021

Current Policy or Practice -

Contract addendum exceeding \$100,000 require County Board approval.

The Resolution will allow continued program evaluation of our Opiate Diversion Program by UW Population Health Institution. This is necessary to assure that Deferred Prosecution is efficiently and effectively accomplishing its mission.
