2015 RES-088 AUTHORIZING THE PURCHASE OF LAND AT CAM-ROCK COUNTY PARK

Brief Description of Proposal -

The Department of Land & Water Resources has recently negotiated the purchase of a large block of property from Gary Rattman on the western edge of the park off Highland Drive, a key acquisition identified in the 2008 Cam-Rock Park Master Plan. The addition would permanently protect over 83 acres, which includes 2,040 linear feet of frontage on Koshkonong Creek and 2,500 linear feet of a tributary stream.

Current Policy or Practice -

Land purchases require County Board approval.

Impact of Adopting Proposal -

The purchase price of \$959,000 for the 83+ acres is based on a fair market appraisal and provides for a lease-back by Mr. Rattman of the farmhouse and buildings for two years and the crop land for five years. This acquisition will provide permanent protection of land and river resources; expanded opportunities for mountain bike trails in an area adjacent to a high concentration of bike trail activity; and provide key lands for the proposed future dog exercise area.
