#### G. Presentations

Lakes & Watershed Commission -

Development of a Liaison or Subcommittee Related to County Natural Resource Issues

Powers discussed the results of the retreat that the Lakes and Watershed Commission sponsored earlier this year. The retreat was an effort to explore building relationships and improving communications between resource committees on common issues. Based on discussions with several Committees including EANR, there's been some agreement to move forward with a couple of recommendations.

- EANR has agreed to host a briefing for all Committees related to common issues. The goal is to provide a forum for staff to provide information to the Committees and the public related to specific topics vs. meeting with each Committee individually.
- EANR, LCC and LWC were all in favor of naming liaisons to help improve communications and the efficiency of working on common issues.

  Park Commission discussion:
- Christine Haag, Supervisor Dave Ripp and Mary Schlaefer agreed to be the primary liaisons and Supervisor Kyle Richmond will assist as the alternate from the Park Commission.
- The Commission recommended that the first task for the liaisons be to outline the purpose and objectives to be served by the group of liaisons.

Park Planners Chris James and Sara Kwitek provided a brief recap of 2014 planning and development accomplishments and the draft 2015 work plan for park planning and development projects.
