I am writing to support petition #12275 for the Madison springs project. It is a good fit for the Vienna township to improve their tax base with a small business that has a good track record and is well known in the area. Vienna has been losing a lot of businesses and tax base due to annexation from DeForest. Madison Springs will be a great small business asset and will serve the needs for area farmers and small businesses.

The proposed area already has many commercial businesses in that area including ATC, MGE, E80, Veterinary clinic, Tri-County Paving, Diehl Neumaier, Madison Sand and Gravel, and Purple Cow so it will fit in well.

I have toured their present shops and was impressed how clean and well designed they are. I noticed all fluids are collected, put in tanks and picked up for recycling.

This rezoning WILL NOT EFFECT THE WETLAND which will remain as it is. It will actually improve the wildlife habitat as it will provide more nesting area with the setbacks required. Presently the setbacks would be farmed. Only 12.5 acres of the 40 acres would be used for development.

Due to the runoff management practices Madison Springs is incorporating (per county and DNR specs) there will be less pollutants entering the wetland than when it was cropland (with the use of pesticides, herbicides, fertilizers, and manure being applied).

As for the noise issues when I toured the present shops there was no excessive noise and the shops they have now are in town and they have had no issues. As far as noise effecting wildlife there is more coming from traffic on highway V than their shop would have. Presently the geese and ducks go right up to the highway sometimes even getting run over by vehicles.

As for the flooding concern from 2009 the proposed area to be built on was not effected as the elevation is much higher or they would not build there. Also the flooding problem was corrected by proper drainage downstream being addressed.

For these reasons I urge you to support Petition #12275

I am writing in support of Petition #12275 to rezone the property at the corner of Patton Rd and Hwy V in the Town of Vienna from agricultural to commercial use for the proposed Madison Spring Truck Parts & Service facility. Madison Sand & Gravel has operated in the Dane County region since 1944 and have been a customer of Madison Spring (formerly HM Repairs) for 4 years. In my experience, Madison Spring operates as a clean, professional, and reliable business that serves small fleets and the agricultural community exceptionally well. Their work has helped keep our equipment running with minimal downtime, which is critical for sand and gravel delivery. Regarding concerns raised by some opponents:

- Noise: At their current facilities, shop activity is not disruptive. I have not noticed significant noise from the parking lot or surrounding areas. The planned air conditioning at the new Vienna location should further minimize open bay doors and sound travel.
- Traffic and location: Existing traffic noise on County Highway V already exists in the area. The proposed site appears well-positioned relative to the wetlands.
