Resolution to Adopt the Comprehensively Revised Dane County Zoning Ordinance

The Town Board of the Town of Medina, Dane County, Wisconsin do adopt and resolve as follows:

- 1. The Town of Medina desires to promote the health, safety, convenience and general welfare of the residents of the Town and to encourage planned and orderly land use and development.**
- 2. The County Board of Dane County, Wisconsin has adopted a comprehensive revision of zoning ordinance for the physical development and zoning of territory within Dane County.**
- 3. The Dane County Zoning Ordinance may become effective in the Town of Medina upon approval of the ordinance by the Town Board.**

NOW THEREFORE, be it resolved that:

Pursuant to Section 59.69(5)(c), Wisconsin Statutes, the Town Board of Medina hereby approves and adopts the Dane County Zoning Ordinance as described in Dane County Ordinance Amendment 2018-OA-20 and shall take all required actions to make the Dane County Zoning Ordinance applicable with the Town of Medina.

This resolution shall take effect on the date of filing with the Dane County Clerk a certified copy of this resolution, together with a copy of the Dane County ordinance amendment 2018-OA-20, and associated zoning map for the Town of Medina (both attached as Exhibit A).

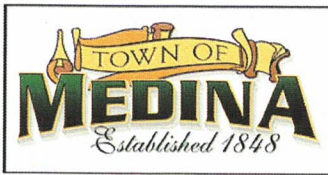

Town of Medina

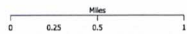
