Dane County is considering amendments (2023-OA-080) to the *Dane County Comprehensive Plan* that would:

- Establish a standing Cultural Heritage Preservation Commission in accordance with Chapter 5 of the Dane County Comprehensive Plan.
- Assign duties and responsibilities to the Heritage Preservation Commission as adopted by the Zoning and Land Regulation (ZLR) Committee

In order to comply with the requirements of the state comprehensive planning law, Dane County must notify all local government jurisdictions within or adjacent to the county, giving them a 30 day review period prior to the county public hearing.
