## D. Presentations

### LUSSIER MEAL SITE

*NewBridge Madison Senior Services Director Sonya Lindquist, who began oversight of all Senior Nutrition Sites in Madison with the merger of the four city aging coalitions on 1 January 2019, reported she is in the process of standardizing operations at the sites. Among her priorities are ensuring all sites are ServSafe Certified, improving volunteer training and reducing waste.*

*Velasquez stated that during the committee's most recent visit to the Lussier Community Education Center, members commented that serving the meal in a gymnasium with high ceilings and exposed pipes makes for a drafty, noisy and uninviting atmosphere. Current committee members concurred, and stated parking is inadequate as well. Velasquez stated the site was reduced from two meals per week to one a few years ago due to low numbers. The site, which serves on Fridays to coincide with the day Lussier's food pantry is open, averages slightly above the 15 diners per day required to secure funding from Dane County.*

*Velasquez provided an overview of the work plan and answered committee members' questions.*

### 2. 2020 BUDGET PRIORITIES

*Velasquez stated action regarding Nutrition/Wellness Committee priorities for the 2020 AAA budget will be required at the April meeting. Among items likely to be considered are increasing funding for meals, allocating funding for shelf-stable emergency meals, and whether funding should be appropriated for home-delivered meals recipients who are at high risk for malnutrition to receive more than one meal per day.*

*Velasquez stated the meal site at Fisher-Taft Apartments in south Madison has averaged 11 diners per day over the past eight months – below the 15-diner average required to continue funding the site. There are five-day meal sites 1 mile and 2.7 miles from Fisher-Taft. It's possible funding for the Fisher-Taft site will be discontinued in the 2020 budget and shifted to a new site in a high-need area of the city. NewBridge would need to propose a new site by June for funding to be available in 2020.*
