Blanket Rezone Process – Town of Sun Prairie

Staff met with the Town of Sun Prairie to discuss the concept of the Blanket Rezone and what it meant for the Town and the Landowners. The Town then scheduled a public meeting on April 21, 2014 at the Town Hall to help facilitate this Blanket Rezone and answer landowner questions. Affected landowners received a direct mailing notification.

Farmland Preservation Plan Rezones (FPP). Required by DATCP, these rezones were identified because of location of certain parcels inside the Sun Prairie and Cottage Grove Urban Service Areas. There are a total of 17 land owners and 31 tax parcels affected; all land owners listed have had a chance to respond via phone, email or at the Town meeting.

The Town of Sun Prairie Board approved the final list on 4/28/2014 with the stipulation a Deed Notice be filed on each of the parcels. If approved, the zoning in the Town of Sun Prairie will be consistent with the Dane County Farmland Preservation Plan and therefore eligible for the state Farmland Preservation Tax Credits.
