

**AUTHORIZING TEMPORARY LIMITED EASEMENT INVOLVING
LAND AT THE DANE COUNTY REGIONAL AIRPORT**

The Wisconsin Department of Transportation (the "DOT") is replacing pavement on U.S. 51 from U.S. 151 to Pierstorff Street as part of Transportation Project Plat 5410-00-24 – 4.01 and has requested that Dane County grant the DOT a 282 square foot temporary limited easement for grading purposes on County owned land near the Dane County Regional Airport at the intersection of U.S. 51 and Anderson Street. The DOT has also requested Dane County sign an accompanying Statement to Construction Engineer. After construction is completed, the DOT will restore the disturbed land and soil to its condition prior to construction. The DOT's use of the temporary limited easement will not impact airport operations, and all work and remediation will be warranted and maintained by the DOT and its contractors.

NOW, THEREFORE, BE IT RESOLVED that the Dane County Executive and the Dane County Clerk are authorized to execute on behalf of Dane County a Temporary Limited Easement and Statement to Construction Engineer, as set forth above.

THIS EASEMENT, made by **Dane County, Wisconsin**, GRANTOR, conveys a temporary limited easement as described below to the **Wisconsin Department of Transportation**, GRANTEE, for the sum of **Four Hundred and 00/100 Dollars (\$400.00)** for the purpose of **Grading**.

Any person named in this conveyance may make an appeal from the amount of compensation within six months after the date of recording of this conveyance as set forth in s. 32.05(2a) Wisconsin Statutes. For the purpose of any such appeal, the amount of compensation stated on the conveyance shall be treated as the award, and the date the conveyance is recorded shall be treated as the date of taking and the date of evaluation.

Upon completion of the construction and/or grading of the property (or as soon after as weather reasonably permits), Grantee shall promptly restore the property in a manner reasonably satisfactory to Grantor.

Grantee shall not use or authorize others to use the property in such a manner as to create electrical or electronic interference with radio transmission or reception between aircraft and any air, navigational, or aviation communications installation upon or in the vicinity of Grantor's airport, or in such manner as to make it difficult for pilots to distinguish between airport lights and other lights or so as to otherwise impair pilots' visual perception in the vicinity of the airport or as to otherwise endanger the landing, taking off, or maneuvering of aircraft in the vicinity of said airport.
