**F. Presentations**

1. Friends of CamRock County Park

*Janice Redford has been involved with the park since the beginning. She shared the history of the park and the Friends of CamRock Park. The Friends have been monitoring the Koshkonong Creek for more than 21 years and they have a very active chainsaw restoration crew.*

## 2. Capital Off Road Pathfinders (CORP)

*Trail Steward Mitch Love and CORP President Jon Augspurger described the history of CORP and the trail systems they build and maintain at CamRock and in other locations. They highlighted the youth NICA team which practices at CamRock and maxed out at over 100 participants this season.*

## 3. Friends of the CamRock to Glacial-Drumlin Connector Trail

*Steve Struss shared the history of the Friends of CamRock Glacial Drumlin Bike Connector Trail, which started as an ad-hoc committee of Cambridge and is now in the process of incorporating as a non-profit. The first phase of the trail will be named after Phil Van Valkenberg. Steve invited everyone to the dedication and groundbreaking on August 1, 2021, starting at 3 PM at the Cambridge Winery.*

## 4. Beer Cave Restoration Update

*Richard Moen shared his history growing up in Rockdale and playing in the beer cave. He has volunteered in the park since 1980 and started restoring the beer cave last year. He detailed the restoration process and the interest from the park users. His progress was recently highlighted in an article in the Cambridge News & Deerfield Independent on June 2, 2021. He hopes to finish the restoration this year and hold a celebration in September.*

## 5. Cambridge Tree Project

*Jay Weiss reported that the Cambridge Tree Project was created to increase species diversity of the community forest and to add 1,000 trees to Cambridge by 2020. They have reached both goals. They have donated over 200 trees to CamRock County Park throughout the years and many to the Dane County Parks forestry program.*

## 6. Foundation for Dane County Parks

*Bill Lunney highlighted the Foundation's recent initiatives, including "Healthy Parks, Healthy You," the new park passport program and the endowment's growth. Bill also invited everyone to Darren's public retirement celebration, hosted by the Foundation, on September 9, 2021.*
