AMENDING CHAPTER 6 OF THE DANE COUNTY CODE OF ORDINANCES,  
REGARDING COMPENSATION OF THE COUNTY BOARD

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 6.03(1) is amended to read as follows:

**6.03 COMPENSATION OF COUNTY BOARD SUPERVISORS.**

(1) Except for the county board chairperson, county board supervisors shall receive an annual salary of ~~\$8,200~~\$10,725., payable as set forth in s. 6.045.

~~(a) Effective with the third Tuesday in April of 2018, county board supervisors shall receive an annual salary of \$10,550.~~

~~(b) Effective with the third Tuesday in April of 2019, county board supervisors shall receive an annual salary of \$10,725.~~

~~(ca)~~ Effective with the third Tuesday in April of 2020, county board supervisors shall receive an annual salary of \$10,900.

(b) Effective with the third Tuesday in April of 2021, county board supervisors shall receive an annual salary of \$11,227.

(c) In addition to the salary set forth above, with the exception of the Executive Committee, supervisors who serve as chair of a standing committee or the Extension Committee and Land Conservation Committee shall receive an additional salary of \$100 per month.

(d) The annual salary due county board supervisors shall be paid in bi-weekly installments. Increases in annual salary shall be paid as set forth in s. 6.045.

ARTICLE 3. Section 6.04(1) is amended to read as follows:

**6.04 COMPENSATION OF COUNTY BOARD CHAIRPERSON.** (1) In lieu of any and all compensation of the types provided for in sec. 6.03, the chairperson shall receive as total compensation an annual salary of ~~\$37,000~~\$50,750., payable as set forth in s. 6.045.

~~(a) Effective with the third Tuesday in April of 2018, the county board chairperson shall receive an annual salary of \$50,000.~~

~~(b) Effective with the third Tuesday in April of 2019, the county board chairperson shall receive an annual salary of \$50,750.~~

~~(ca)~~ Effective with the third Tuesday in April of 2020, the county board chairperson shall receive an annual salary of \$51,500.

(b) Effective with the third Tuesday in April of 2021, the county board chairperson shall receive an annual salary of \$53,045.

(dc) The annual salary due the county board chairperson shall be paid in bi-weekly installments. Increases in annual salary shall be paid as set forth in s. 6.045.

49 ARTICLE 4. Section 6.045 is rescinded :

57 ~~who leaves in the month of April of an election year, shall have his or her salary~~

59 ~~replacement, if any, shall have his or her salary pro-rated for the month in which~~
