[ACT-028](#) POSSIBLE RECOMMENDATION ON JAIL OPTIONS

Nelson explains the history of the project and informs committees that there are 22 registrations with only 12 speakers.

Supervisor Rusk moves that the PP&J committee endorses the South Tower Addition Option to consolidate the Dane County Jail facilities at a cost of approximately \$150 million. This option will conform to the original Option 3, Phase 1 Program that was approved in 2017; Seconded by Schwellenbach.

Supervisor Kiefer moves to adopt Rusk motion with friendly amendment to substitute PP&J with PW&T. Schaurer seconds.
