ACCEPTING REVENUE AND AUTHORIZING EXPENDITURES FOR GRANT MAKING FOR K-12 EMOTIONAL WELLNESS AND MENTAL HEALTH SUPPORT GRANTS DCDHS – PEI DIVISION

Policy Analysis Statement:

Brief Description of Proposal -
Dane County Department of Human Services' (DCDHS) Prevention and Early Intervention Division (PEI) is seeking spending authority to utilize American Rescue Plan (ARP) of 2021 funds to provide bridge funding to Dane County area school districts to meet mental health and wellness needs of Dane County K-12 students. PEI is seeking funding authority to offer and allocate one-time grants to Dane County Public School Districts to assist K-12 students and their parents/caregivers in meeting student mental health and wellness needs during the transitional period of re-entry to physical school settings during the continued COVID-19 pandemic.

Current Policy or Practice -
Budget changes and major contracts require County Board approval.

Impact of Adopting Proposal -
All grant awards will be under \$100,000 except for Madison Metropolitan School District (\$454,754), Oregon School District \$103,119) and Verona Area School District (\$450,000).
