Brief Description of Proposal -

The Department of Waste & Renewables paid the required fee for District connection charges for Lot 1 of the Sustainability Campus and Dane County Landfill No 3 site in September 2023. Remaining charges are now due for additional areas that will be served by the sanitary system. The Department of Waste & Renewables, City of Madison, and Madison Metropolitan Sewerage District have agreed on the connection charges currently due.
