1. 2024 County Executive Agard Introduction and Questions PRES-201

County Executive Agard introduced herself and provided remarks to the committee regarding the future of AEC.

Believes now is the time to renovate the Veterans Memorial Coliseum

Coliseum facility is outdated and does not have the facilities and infrastructure that performers require

Renovation is about what is good for the community

Thanked committee for support of RFP process

Priority that renovation of Coliseum will not slow down progress on Exhibition Hall

Putting together plan to go to state for funding for Exhibition Hall expansion

Introduced Lacy Fox as County Lobbyist

Questions ensued Knox noted that he will continue to bring up a potential youth sports facility

DeChant inquired about the public hearing happening later this week.

Clarified that County Exec and Scheibler will both be providing robust remarks

Christenson pleased of the County Exec's support and willingness to work with County Lobbyist

County Exec stressed that continued conversations will provide information around the direction forward

Stouder shared excitement from the City's side for the momentum of the project and eager to be strong partner

Stouffer noted the importance of stressing in the messaging that the renovation will target a diverse range of types of events

Miles asked for more information on the owner rep – Scheibler clarified that the owner rep will help meet the goals

Stouder asked about how ownership models may change based on the public – private investment/structure – Scheibler indicated discussions will be had

DeChant asked if owner rep will be brought on during the RFP drafting process, Scheibler clarified that they will
