# **Policy Analysis Statement:**

### Brief Description of Proposal -

The Department of Transportation (DOT), Bureau of Transportation Safety, State of Wisconsin, provided grant funding in the am ount of \$43,900, as authorized by 2014 RES-606 to create a Sheriff's Traffic and OWI Patrol Task Force, project period 10/1/2014 - 9/30/15. DOT is providing an additional \$27,646 in funding for a total of \$71,546 towards this effort; \$10,000 for enforcement by Dane County, \$12,646 to be administered and paid to the other participating Sheriff's Office agencies, and \$5,000 to purchase traffic safety vests for Deputies participating in the program.

## Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

## Impact of Adopting Proposal -

During 2013, in Wisconsin, alcohol-impaired driving was listed as a contributing factor in 4.2% of all crashes. 35.1% of all vehicle crash fatalities in 2013 were alcohol-related, resulting in 185 deaths. Alcohol-impaired driving is associated with other high-risk behaviors that increase the likelihood of a crash and of significant injury or death including speeding and failure to wear safety belts. Implementation of this project will save lives and make the roads safer for vehicles and pedestrians.
