#### D. Presentations

1. New Family Day Services – Jeanne Erickson, Project Babies: Family day services now available at Today Not Tomorrow Family Resource Center, located at the East Madison Community Center (8 Strauble Court). It will be open Monday-Friday 10am-12pm and provide a space for free play, activities, various parent education resources for families with young children. Hours anticipated to expand to 10am – 4pm in June.

2. Family Shelter Update – The Salvation Army, The YWCA, The Road Home: Family shelter providers present on process to access shelter and information on their programs. The Salvation Army updated the committee on services currently offered and capacity since they converted their 90-day program to a drop-in overnight family shelter in November of 2016. Their capacity for emergency family shelter is now 91 people. The shelter has been able to serve all families requesting shelter except for five nights in April 2017. Accommodations were ultimately made for some due to guest cancellations. Discussion of service gaps seen in system. Additional units of permanent supportive housing, rapid re-housing are needed. Challenge finding landlords who will rent to program participants. Discussion of increasing coordination between public housing authorities and housing programs as has been done in other communities.

3. Families Living in Hotels and Barriers They Face – Madison Metropolitan School District Transitional Education Program Staff: TEP Staff work with Operation Giving Hope to provide services (connection to resources, clothing, other supplies) to families living in motels. 33 homeless families were identified during "knock and talk" in August of last year. 13% children identified by the school system as homeless live in motels. They are not considered homeless in HUD definition and do not qualify for HUD funded homeless services. Another 70% students are in doubled up situation and also do not qualify for the HUD funded housing and services. Limited case management services are available for families who do not meet the HUD definition of homeless, but there are barriers to access these resources including transportation. Many families have income, but face many challenges that prevent them from acquiring permanent housing on their own. TEP staff would like to see dedicated case managers and housing locators for families who do not meet the HUD definition of homeless.

4. Built for Zero Update: Sarah Lim and Casey Becker reported. The City of Madison/Dane County Continuum of Care has reached functional zero for chronically homeless veterans. Still have to find housing for around 60 veterans to reach functional zero for the entire population of veterans who are homeless. City, County, VA, and Tenant Resource Center staff attended the Community Solutions Built for Zero learning session April 25 – 26th. Learned about national best practices to more efficiently deliver services and end homelessness. Worked on a four-month plan that will be fleshed out and shared with stakeholders to reduce the number of homeless veterans, individuals who are chronically homeless, and refine the community's by-name list to more accurately reflect our need. Also learned about ways to partner housing programs with public housing authorities, and address inflow to the homeless system through diversion best practices.
