Second Addendum to Employment Services Agreement

COUNTY OF DANE

This Second Addendum, made and entered into by and between the County of Dane (hereinafter referred to as "EMPLOYER") and Tracy Herold (hereinafter, "EMPLOYEE"),

WITNESSETH:

WHEREAS, the EMPLOYER and the EMPLOYEE have by a separate document entitled Employment Services Agreement (hereinafter the "Original Agreement") previously entered into a contractual relationship, and

WHEREAS, the EMPLOYER and the EMPLOYEE entered into an Addendum to Agreement ("First Addendum") which extended the Original Agreement for five years ending January 11, 2025, and

WHEREAS, the EMPLOYER and the EMPLOYEE now wish to extend the term of the Original Agreement for an additional five

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Original Agreement and the First Addendum shall remain in full force and effect unchanged in any manner by this Second Addendum to Employment Services Agreement except for those changes expressly set forth herein. This Second Addendum to Employment Services Agreement shall control only to the extent of any conflict between the terms of the Original Agreement and the First Addendum.
