Title of Resolution or Ord. Amd.:

ESTABLISHING AN EQUITY FOOD PROGRAM FOR 2020

Policy Analysis Statement:

Brief Description of Proposal -

This resolution would authorize the establishment of a 2020 Food Equity Program that will provide services to specific classes of individuals in the Dane County community that are in need of access or availability to food. The resolution also authorizes the Office for Equity and Inclusion (OEI) to operate the program.

Current Policy or Practice -

The establishment of a program for relief requires Dane County Board approval.

Impact of Adopting Proposal -

Establishing a food equity program for 2020 will authorize OEI to contract with the service providers who can assist the classes of individuals identified in the resolution. Through a grant process, OEI has identified the service providers who are able to provide relief, and OEI already has \$20,000 in its budget to fund these services.
