Contracted for April - October - 6 month design progress

a. Veterans Memorial Coliseum Financial Assessment Update

Scheibler reviewed takeaways from Hunden report including:

- Renovation returns nearly same number of events at a significantly less capital cost
- Renovated Coliseum returns an estimated \$59 million in annual economic impact
- Renovated Coliseum generates 141 annual FTE's

Scheibler did a review of performance numbers and a comparison of other facilities

Scheibler reviewed the projected revenue for the facility
