**Title of Resolution or Ord. Amd.:**

AUTHORIZING AGREEMENT WITH GREATER MADISON CONVENTION AND VISITORS BUREAU, INC., DBA DESTINATION MADISON, TO PROVIDE VISITOR INFORMATION AT THE DANE COUNTY REGIONAL AIRPORT

**Policy Analysis Statement:**

Brief Description of Proposal -

This resolution authorizes Destination Madison to provide visitor services for the Airport Visitor Information Center in the Terminal Building at the Dane County Regional Airport. The agreement begins January 1, 2020.

Current Policy or Practice -

Destination Madison provides visitor services for the Airport Visitor Information Center under an agreement expiring December 31, 2019.

Impact of Adopting Proposal -

The Airport Visitor Information Center will continue to provide visitor services through Destination Madison for a period of three years, expiring December 31, 2022.
