F. Presentations

1. Walking Iron Wildlife Area Restoration Progress

Lars Higdon, Dane County Parks Botanist/Naturalist, detailed the Walking Iron Wildlife Area restoration work progress, including black locust removal and oak savannah restoration. Workdays are held the 2nd and 4th Tuesday of every month.

2. Walking Iron Wildlife Area 7A Wetland Restoration Plan

Joleen Stinson, Interim Parks Director, provided details on a ~360 acre wetland restoration project planned in partnership with Ducks Unlimited and the US Fish and Wildlife Service. Work to be completed in 2022.

3. Village of Mazomanie

Mark Geisler, Village of Mazomanie Public Works Director, discussed recent village park improvement projects, including a new downtown music pavilion, opening a dog park in Lions Park and Lake Marion restoration. He introduced Gail and Russ Dengel, volunteers restoring the prairie on the Village's bluff. Peter Huebner, Village of Mazomanie Administrator, detailed the Black Earth Creek flood damage repair project, funded by Community Development Block Grant Disaster Relief and Recovery Funds.

4. Gateway to the Driftless

Chris Long introduced Gateway to the Driftless Board Members Ben Swanson, Peter Antonie, Sara Shackleton, and Mary Scott. He provided a history of the organization and detailed the group's mission as a facilitator to bring other groups together through public/private partnerships. Mary Scott highlighted the Park passport program, which includes several Dane County Park properties around Mazomanie, Black Earth and Cross Plains.

5. Friends of Mazo Marsh

Dan Deneen, Friends of Mazo Marsh President, provided the history of this non-profit organization. They started with a focus on clearing blockages in Black Earth Creek to the Wisconsin River. Now they're working on trail connections through Walking Iron Wildlife Area and the WDNR Lower Wisconsin Riverway property.
