**AUTHORIZING GRANT FUNDING FROM THE FY2024 USDA COMPOSTING AND FOOD WASTE REDUCTION GRANT**

Brief Description of Proposal -

The Department of Waste & Renewables reports the receipt of award from the US Department of Agriculture's Compost and Food Waste Reduction grant program. The grant spans two years, from June 1, 2024 through May 31, 2026 and funds an organics collection kiosk program in Dane County. The total award is \$400,000.00.
