1. **PRES-096** FOLLOW UP ON HOUSING STUDY - KURT PAULSEN & OLIVIA **PARRY**

Senior Planner Olivia Parry from Dane County Planning and Development updated HSB members about the progression of Res. 92 - Housing is a Human Right. Parry advised members that staff will have a meeting on Friday, October 31st at 345 W. Washington Avenue to discuss the Housing Report and how the County should effectively move forward with a structured plan.

On Monday, November 3rd Parry will have an informal meeting with outlining community leaders in Dane County and the City of Madison. Leaders will be presented with the Housing Report and incorporate how the report pertains to their community and come up with a partnership plan.

Parry will send out an Agenda so HSB members can stay informed about the topics being discussed at the meetings.

1. RPT-437 Budget Update: Wegleitner Amendment (HHN 1 Capital Budget) \$8M Building Solutions to Homelessness

The Budget Amendment proposes \$8 million for expansion of affordable housing and homeless services in Dane County, HHN passed this Budget Amendment.
