**AWARD OF CONTRACT FOR ENVIRONMENTAL SITE INVESTIGATION OF THE
DARWIN TRAINING AREA AT THE DANE COUNTY REGIONAL AIRPORT**

Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Regional Airport ("Airport") led an initial investigation for the presence of PFAS at the Darwin Training Area location at the Airport. The Airport engaged ORIN Technologies, LLC ("ORIN") to conduct an environmental site investigation of the Darwin Training Area to determine the extent of the presence of PFAS. Now, the Airport has engaged ORIN to perform remediation work at this site. Under this contract, ORIN will (1) treat PFAS contamination in both soil and groundwater, (2) monitor soil and groundwater performance and other groundwater metrics, and (3) complete a formal report of the remediation work. Work is to be completed by December 31, 2026. The maximum cost of this contract is \$1,500,000.00, which is the current best estimate of the project scope. The Airport will also seek funding from other sources to help pay for this contract.

Current Policy or Practice -

The Airport has engaged ORIN Technologies to investigate the Darwin Training Area for contamination.

Impact of Adopting Proposal -

The Darwin Training Area site will receive remediation and monitoring for PFAS contamination.
