4. Change #5 to read, "Assist with review and update from AAA staff of the Case Management formula. Includes regarding factors and weights considered to be primary indicators of greatest economic and social issues of Dane County older adults."
5. Change #6 to read at the end, "as directed by the current Dane County Aging Plan, Work Plan and supporting any other advocacy efforts of AAA."
