Amending Chapter 10 of the Dane County Code of Ordinances  
Zoning Map Amendment Petition 11004**

Dane County Board of Supervisors does ordain as follows:

The Zoning Districts Maps as referenced under Dane County Code of Ordinance Section 10.03 shall be amended as follows:

**Town Map:** Town of Albion

**Location:** Section 2

**Zoning District Boundary Changes**

**A-1EX to A-2(8)**

PART OF THE SE 1/4 OF THE SW 1/4 AND PART OF THE NE 1/4 OF THE SW 1/4 OF SECTION 2, T.5N., R.12E. OF THE 4<sup>TH</sup> P.M., TOWN OF ALBION, DANE COUNTY, WISCONSIN.

Described As Follows: Commencing at the South 1/4 Corner of said Section; thence N.0°34'40"W. along the North-South Centerline of said Section; 415.00 feet to the place of beginning for the land to be herein described; thence S.89°25'20"W. 60.00 feet; thence N.28°56'35"W. 600.66 feet; thence N.16°20'01"W. 408.03 feet; thence N.37°57'13"W. 181.04 feet; thence N.0°32'22"W. 136.73 feet; thence EAST 5660 feet to said North-South Centerline; thence S.0°34'40"E. along said North-South Centerline, 1196.13 feet to the place of beginning.

Described As Follows: Beginning at an aluminum monument at the South 1/4 Corner of said Section; thence S.88°42'25"W. along the South Line of the SW 1/4 of said Section, 661.01 feet to the West Line of the East 1/2 of the East 1/2 of the SW 1/4 of said Section; thence N.0°39'20"W. along said West Line, 1994.37 feet to the North Line of the SE 1/4 of the NE 1/4 of the SW 1/4 of said Section; thence N.89°04'43"E. along said North Line, 663.68 feet to the North-South Centerline of said Section; thence S.0°34'40"E. along said North-South Centerline, 378.97 feet; thence West 566.00 feet; thence S.0°32'22"E. 136.73 feet; thence S.37°57'13"E. 181.04 feet; thence S.16°20'01"E. 408.03 feet; thence S.28°56'35"E. 600.66 feet; thence N.89°25'20"E. 60.00 feet to said North-South Centerline; thence S.0°34'40"E. along said North-South Centerline, 415.00 feet to the place of beginning.

## **CONDITIONAL ZONING**

Conditional zoning is hereby imposed pursuant to Section 10.255(3)(a)2.(b) of the Dane County Code of Ordinances. The rezoned area shall be subject to the following conditions.

### **CERTIFIED SURVEY REQUIRED**

The above listed description/s is/are intended to describe land for which a certified survey map will be prepared for approval and recorded. Within 90 days of rezoning approval by Dane County, a *final* certified survey map that describes the land to be rezoned shall be prepared in accordance with all applicable provisions of Chapter 236 Wisconsin Statutes and Chapter 75 Dane County Code of Ordinances, and submitted to the Dane County Zoning Division. Upon submission of the final certified survey map, the Zoning and Land Regulation Committee, or its authorized representative, shall, within 30 days, approve, approve conditionally, or reject the certified survey map. **Failure to submit the final certified survey within the 90 day period and/or failure to record the survey with the Dane County Register of Deeds will cause the rezone to be null and void. Two copies of the recorded survey shall be submitted to Dane County Zoning.**
