DISCUSSION OF FUTURE ROLE OF THE LTS COMMITTEE

Genter reviewed the changes proposed in the 2015-2017 State Budget that would impact programs for which the Long Term Support Committee provides oversight. He noted that there has been lots of statewide advocacy to remove some of the proposals from the budget, and that final decisions on the budget are not expected until late May. One of the proposals is to delete the statutory requirement for Long Term Support Committees. Committee members discussed what roles the LTS Committee might play if the state budget is adopted as proposed and LTS Committees are no longer required. The following roles were suggested: a) Be designated the required Children's COP committee; b) Continue to provide advisory oversight of programs not impacted by the state budget including Badger Prairie HCC, adult mental health, adult protective services, HIV services, etc., c) Seek community input on the transition to Family Care and provide input/advice to county and state officials on the transition, and d) once Family Care is implemented in Dane County, seek input from consumers and assist consumers in providing feedback to state officials. Yochum recommended that the LTS Committee initiate a conversation with the Health and Human Needs Committee regarding the state's proposed changes and the future roles of the LTS Committee.

A motion was made by WEGLEITNER, seconded by BLOTNER, that the Long Term Support Committee seek a meeting with the chair of the Health and Human Needs Committee on the impact of the 2015-2017 State Budget on programs that the LTS Committee oversees and how the LTS Committee and Health and Human Needs Committee can work together to provide support for Dane County residents.

Genter shared historical information on days of inpatient care at Mendota and Winnebago Mental Health Institutes. For 2009 - 2014, the annual average has been 4,266 days of care, ranging from a high of 4,753 days in 2010 to a low of 3,806 days in 2012. Genter reported that the annual DCDHS Request for Proposals process has begun. RFPs are posted on the DCDHS web site, and the due date for all RFPs is May 23rd. Among the RFPs, eight RFP's are for adult services and one is for BPHCC services. There are also RFPs for children's services and housing services.
