**Policy Analysis Statement:**

Brief Description of Proposal -

The Friends of Pheasant Branch Conservancy have donated \$20,400 to support the funding of an LTE dedicated to working with volunteer groups in the Pheasant Branch Conservancy.

Current Policy or Practice -

Acceptance of donations for LTE funds requires county board approval.

Impact of Adopting Proposal -

Account LWRPKOP 81566 Donation Revenue will be increased by \$20,400, account LWRPKOP 10076 Pheasant Branch LTE Expense will be increased \$18,950 and account LWRPKOP 10108 Social Security Expense will be increased by \$1,450. These funds shall carry forward until expended.
