

## SIXTH ADDITION TO SMITH'S CROSSING

CITY OF SUN PRAIRIE, DANE COUNTY, WISCONSIN



1. The environmental corridor is defined on this plat as Outlots 68, 69, 70, 72, 73, 77 AND 78 as well as portions of all private lots and outlots over which the 100-year Flood Plain and 75-foot wetland buffers are located.

2. 75-foot wetland buffer line is contained within the platted outlots unless otherwise shown on plat. The only permitted uses in the wetland buffer area is landscaping and vegetation.

3. The 100-year Flood Plain (Post Development Limit), as shown on this plat, is based on the "New Town Development Channel Modification Flood Plain Study for Unnamed Tributary to Koshkonong Creek" dated October 26, 2001 and adopted by the City of Sun Prairie October 15, 2002. Lots affected by the Flood Plain are subject to the conditions and restrictions contained in said study.

4. Minimum unprotected building foundation opening elevation shall be 2 feet above the 100-year flood elevation. The elevations listed for the affected lots of this plat are the minimum unprotected building foundation opening elevations. City of Sun

5. —— Arrows indicate the direction of drainage flows in various components resulting from site grading and the constrcution of required public improvements. The drainage flow components located in t easeemtns sahl! be maintained and preserved by the property owner unless approved by the City Engineer.

6. According to the Soil Survey of Dane County, there exist soils that are subject to seasonal high water table on the following lots: 646-679, 711-733, 738, 739. 746-753, 756-761, 769-778, 781.

7. All streets shall be constructed with 5' concrete sidewalks on both sides.

8. A 20-foot wide temporary fire lane shall be constructed on Outlot 75 to provide access until such time that Wildflower Way and/or Winding Stream Way are extended and provide secondary access as approved by the City of Sun Prairie.

9. Distances shown along curves are chord lengths.
