Lead sponsor Erickson said that the purpose of this resolution is to advocate that DNR reviews of high capacity wells include analysis of cumulative effects, and that Dane County views water conservation as a priority in making decisions.

Public comment: Carl Sinderbrand spoke in opposition. Katherine Odell, Frannie Rowe, and Ted Voth Jr. spoke in support. Jean MacCubbin was available for information. Caryl Terrell registered in support, and distributed a memo from the Capital Region Advocacy Network for Environmental Sustainability (CRANES) with comments on this resolution.

After Commission discussion, Power acknowledged the general support of Res. 391, and the need for some modifications. Members agreed to refer Res. 391 to the Lakes & Watershed Commission Executive Committee for modifications to be considered at the full Commission meeting.

Dane County Lobbyist Mickey Beil handed out copies of "2015 New Wisconsin Assembly Members" and Res. 355.

Public comment: Caryl Terrell registered in support, and distributed a memo from CRANES with comments on this resolution.

A motion was made by UPDIKE, seconded by WEST, that this Resolution be recommended for approval with amended language for the Transportation, Land and the Environment Section, starting on page 6, shown below:

- 23) DNR Budget Reductions: Oppose reductions in DNR staffing that affect Dane County water programs (water regulatory programs, lake/fishery, runoff specialists, conservation wardens, land conservation and parks programs).
- 29) Greenhouse Air Pollution: Reduce greenhouse air pollution by updating and implementing the Governor's Global Warming Task Force recommendations and increasing funding for county energy efficiency measures. Provide funding for county-level climate action planning, mitigation and adaptation.
- 31) American Transmission Company (ATC) Requirement: Urge Wisconsin Public Service Commission to require ATC to construct power lines underground to protect Dane County economic and environmental resources while enhancing resiliency and reliability during extreme weather events.
- 34) Comprehensive Approach to Control Lake Levels: Request the DNR to adopt a comprehensive approach to managing the levels of the lakes through collaboration with affected parties, including dam operators, municipalities and regulatory agencies toward improving natural hydrologic conditions and habitat.

Announcements

Kolar said that the latest "Yahara 101" on monitoring and crowd sourcing was very good. Jones said that the MAMSWaP roadway winter maintenance workshop held earlier in the day (co -sponsored by the Commission) was well attended and well received. Friday's winter maintenance workshop will focus on sidewalks, driveways and parking lots. West said that the Middleton stormwater utility referendum passed with overwhelming support for this funding to maintain stormwater facilities.

2015 Budget

A County Board vote is expected on November 17. Power complimented Commission members for their work to maintain important Office of Lakes and Watersheds capacity to engage citizens in water resources volunteerism and communications.

- o Green Tier Updike reported that a recent tour of commercial and residential construction sites demonstrated that Green Tier participation is making a positive difference in compliance.
- Clean Lakes Alliance -- has a new Executive Director, James Tye.
- o Chair Power noted that a positive aspect of budget deliberations is that more supervisors are aware of the Commission and its role. She also reported that Trina McMahon is not able to devote time to Commission service, and therefore the Commission is seeking potential candidates for this Madison citizen member. Power said that there is an upcoming meeting with Chief of Staff Wescott and Land and Water Resources Director Connors about improving communications regarding land and water resources issues. Natural resources-related Committee and Commission leaders have expressed interest in collaborating on issues of common interest.
