6 **AUTHORIZING TO ACCEPT VAWA GRANT FUNDS AND CREATE A POSITION OF**  
7 **A .50 FTE DOMESTIC VIOLENCE PARALEGAL FOR THE DANE COUNTY DISTRICT**  
8 **ATTORNEY OFFICE,**  
9 **GRANT NUMBER 2012/2013-VA-02BX/02B-10187**

11 The Violence Against Women Act provided a grant through the Department of Justice,  
12 State of Wisconsin, to the Dane County District Attorney Office for a .50 FTE Domestic Violence  
13 paralegal position, Grant Number **2012/2013-VA-02BX/02B-10187**.

14 This funding is through June 30, 2015. The purpose of this federally funded grant is to assist the  
15 Dane County District Attorney's Office with the drafting of in-custody referrals daily, as well as,  
16 summons and warrant criminal complaints related to Domestic Violence crimes. This position  
17 will also be responsible for obtaining 911 calls, photographic evidence and medical  
18 documentation related to Domestic Violence criminal cases and assist Assistant District  
19 Attorneys with creating and organizing their files for court.  
20

21 **NOW, THEREFORE, BE IT RESOLVED** that the Dane County District Attorney Office is  
22 hereby authorized to accept \$44,863 from the Department of Justice.

24 **BE IT FURTHER RESOLVED** that .50 Domestic Violence paralegal position be created  
25 within the Dane County District Attorney office. This position is contingent upon grant funding;

28 **BE IT FURTHER RESOLVED** that \$44,863 is set up as additional revenue in the Dane  
29 County District Attorney Adult Criminal and Traffic Budget new account line named VAWA Grant  
30 (DACTA NEW) and be credited to the General Fund; and

32 **BE IT FURTHER RESOLVED** that \$44,863 is transferred from the General Fund to the
