I, John M. Halverson, professional land surveyor, hereby certify: THAT under the direction of "Nizam" S. Nizamuddin, I have surveyed, divided and mapped the following described parcel of land:

Being part of the SW 1/4 and SE 1/4 of the NE 1/4 of Section 5, T6N, R7E, Town of Springdale, Dane County, Wisconsin, to wit:

Commencing at the E 1/4 corner of said Section 5; thence N 89°47'46" W, 1214.51' along the south line of the NE 1/4 to the POINT OF BEGINNING; thence N 89°47'46" W, 654.67' along the south line of the NE 1/4; thence N 6°49'19" W, 923.36' to the beginning of a curve, concave to the northwest, having a central angle of 8°03'00", a radius of 1910.00', and whose long chord bears N 62°17'27" E, 268.13'; thence 268.35' along the arc of said curve and along the centerline of County Road S; thence N 31°44'03" W, 60.00' to the beginning of a curve, concave to the northwest, having a central angle of 8°19'50", a radius of 1850.00', and whose long chord bears N 54°06'02" E, 268.75'; thence 268.98' along the arc of said curve and along the north right of way line of County Road S; thence S 73°04'28" E, 71.08' to the centerline of County Road S; thence S 25°56'46" E, 64.20'; thence S 43°22'07" W, 116.25' along the south right of way of County Road S and to the beginning of a curve, concave to the northwest, having a central angle of 4°08'40", a radius of 1052.67', and whose long chord bears S 45°26'27" W, 76.13'; thence 76.14' along the arc of said curve and along the south right of way line of County Road S to the beginning of a curve, concave to the west, having a central angle of 14°36'09", a radius of 1133.00', and whose long chord bears S 24°31'55" E, 287.98'; thence 288.76' along the arc of said curve to the beginning of a curve, concave to the west, having a central angle of 149°56'28", a radius of 70.00', and whose long chord bears S 2°33'38" E, 135.21'; thence 183.19 along the arc of said curve; thence S 31°00'00" E, 491.62'; thence S 0°00'00" W, 217.64' to the POINT OF BEGINNING; containing 599,908 square feet or 13.772 acres, more or less.
