Policy Analysis Statement:

Brief Description of Proposal -

However, this position is unfunded in the 2014 budget. A LTE Clerk-Typist I-II has been utilized in the past months to help with clerical support in the division.

Current Policy or Practice -

LTE positions are limited in hours and need County Board approval to be extended past 1,200 hours.
