Budget Amendment EANR-3: Increase operating expenditures in the County Board office by \$40,000 to plan and coordinate restoration of county hydric soils into wetlands.

Amendment # PWT-1: Increase capital expenditures and borrowing by \$17,385 to make improvements in county buildings to provide public access to private spaces to breastfeed or express milk in accordance with 2014 Res. 306. Up to 20 county buildings could be covered by Res. 306, with the airport being the only known facility not requiring improvements. The fiscal note of Res. 306 estimates a maximum cost of \$915 per space for a total maximum cost of \$17,385. It is anticipated that the actual cost will be much less because many buildings will have spaces with at least some of the required features, including chair, outlet, lockset, window treatment, and signage.

A motion was made by Ritt, seconded by de Felice, that the Budget Amendment be recommended for approval. The motion carried by a voice vote. (5-0) YGP 2-0

Amendment # PWT-2: Decrease funding for the Loading Docks project in the AEC Capital budget by \$750,000 and appropriate \$750,000 for GPR funded AEC Improvements and add the following provision to Res-331: "Before any of the \$750,000 appropriated for GPR Funded AEC Improvements in the AEC capital budget is spent on improvements to the Coliseum, staff will obtain the approval of the Public Works and Transportation Committee. Such approval will be based on the economic feasibility of the proposed projects."

A motion was made by Schmidt, seconded by Nelson, that the Budget Amendment be recommended for approval. The motion carried by a voice vote. (5-0) YGP 2-0

Amendment # PWT-3: Increase expenditures and borrowing by \$1.5 million in the Capital Budget for Public Works, Highway, and Transportation for the SMART Fund (previously entitled the Green Energy/Green Jobs Project Fund) to allow departments to implement energy efficiency, alternative energy, and other sustainability initiatives to increase the county's energy independence and decrease pollution. Funds not allocated in 2015 would carry forward.

A motion was made by Schmidt, seconded by Ritt, that the Budget Amendment be recommended for approval. The motion carried by a voice vote. (5-0) YGP 2-0

Amendment # PWT-4: Increase expenditures and borrowing proceeds by \$300,000 for visioning and market analyses for future capital investment at the Alliant Energy Center.
