## **Policy Analysis Statement:**

### Brief Description of Proposal -

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is making funds available for particip ation in a 2016 Motorcycle Enforcement Project, Grant Number FG-2016-DANE CO-03450; activities for this project are funded October 1, 2015 through September 30, 2016. The goal of this high visibility enforcement effort is to increase safety of motorcycle operators and to increase the perception of law enforcement's presence to deter drinking and operating of motorcycles, improve traffic safety, and reduce crashes and fatalities.

#### Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

### Impact of Adopting Proposal -

In Wisconsin during 2012, 5,024 alcohol-related crashes resulted in 223 deaths, or 37.1% of all traffic deaths, and 2,907 injuries. Alcohol-Impaired driving is commonly associated with other high-risk behaviors that increase the likelihood of a crash and of significant injury or death occurring. These high-risk behaviors include speeding, failure to wear safety belts, and distracted driving. Further, in 2012 there were 2,964 motorcycle crashes in Wisconsin. Though motorcycle vehicle miles traveled make up a very small percentage of overall vehicle miles traveled on Wisconsin roadways, motorcycle fatalities in 2012 accounted for 18% of all traffic related fatalities.
