AUTHORIZING HIGHWAY SAFETY GRANT FUNDING FOR A SPEED ENFORCEMENT TASK FORCE PROJECT

Policy Analysis Statement:

Brief Description of Proposal -

The WI Department of Transportation, Bureau of Transportation Safety, is making funds available for participation in a 2021 Speed Enforcement Task Force Project, Grant Number FG-2021-DANE CO-05679; grant project period is June 1, 2021 through September 30, 2021. The goal of this federally funded enforcement project is to reduce traffic crashes in Dane County by focusing on speeding violations, aggressive driving, and seatbelt violations. Participating agencies in this enforcement effort are the Sheriff's Office and Madison Police Department, who will adopt a zero tolerance for impaired driving, and unrestrained occupants during all motor vehicle stops. The Dane County Sheriff's Office will be the administrator

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

In Wisconsin during 2019, speed-related crashes were listed as a contributing factor in 15.0% of all crashes, and almost 28.0% of all fatal crashes. A total of 160 people died in these crashes. Excessive speed is often associated with other high-risk behaviors that increase the likelihood of a crash and of significant injury or death occurring; these include following too closely and failure to wear seat belts.
