Marsh reviewed the approval process used by the Park Commission to set park fees. Marsh stated that he had three individuals contact him related to the proposed 2019 fees. All were in favor of the fee increases.

Mike Batka, owner of Glide Disc Golf in Madison, offered a proposal to the commission regarding the possibility of a half-day tournament rental fee for disc golf courses. Marsh stated that he sought input from staff related to the proposal and the staff were in favor of offering a half-day block of time of four hours for small tournaments. The commission thought this was a reasonable option vs a full-day option. The commission asked Marsh to pass along their thanks to Mr. Batka for his creative idea to allow for smaller tournaments while still maximizing public use of the course.

LUNNEY stated that if the commission was in support of this suggestion, that they amend the 2019 proposed fee increase to include a half-day, four-hour block tournament rental option on the disc golf courses.

A motion was made by THORESEN, seconded by BROUWER, that this action item be approved with the ammendment that a half-day (four-hour) tournament rental option be offered for \$100. The motion carried by the following vote: 6/0, YGP: 1/0

F. Presentations

1. Friends of Schumacher Farm

Jim Ableidinger provided project updates at the park including residing and painting the old barn, new floor for the lean-to, barn quilt for Center for Rural History, new accessible pathway to the house, and a tractor purchase to assist with maintenance at the park. Steve Keip explained park programming including their activity calendar and mentioned upcoming events such Halloween at the Farm, holiday teas, woodstove cooking, and photography/nature programs such as a butterfly workshop. Amy Joe Dusick, Staff Manager, mentioned snowshoe and ski events, summer camp and school educational events. She also reported that they had about 300 registered volunteers assisting at the park.

2. Center for Rural History

Jim Ableidinger provided an overview of the Center for Rural History including how the project finally is becoming a reality. He then discussed how the center will serve the Friends and provide a great venue for the community.

3. Dane County Parks Foundation

Lunney provided an update on the work of the Friends of Dane County Parks. He stated that the Friends Board has approved a name change that everyone feels will provide more clarity in their role with Dane County and the other friends groups. The new name is "The Foundation for Dane County Parks."

H. Announcements

Marsh stated that on Tuesday, September 25th there was a Cooperative Dog Park Informational Meeting that covered two suggested rule changes for the cooperative program. The proposed rules were to limit handlers to three dogs and to create a definition for which dogs can use the "small dog areas." Marsh and Stangel-Maier stated that there will be another informational meeting on October 10, 2018 at the Verona Library covering the land management at Prairie Moraine Park.

WISNIEWSKI announced a couple of awards that recognized former staff. Jan Zimmermann, who retired last year from Dane County Land & Water Resources Department, received the Harold "Bud" Jordahl Lifetime Achievement Award at the Gathering Waters Event and Topf Wells will be recognized by the River Alliance as a 2018 River Champion for Wisconsin. LUNNEY mentioned that due to the work of Mike Slavney and Andy Lewis the Lewis Nine-Springs E-Way has been recognized as a "Wisconsin Great Place" by the American Planners Association, Wisconsin Chapter. The award will be given out on October 9, 2018. James stated the Lower Yahara River Trail had recently won "The Daily Reporter Top Project of 2017" award.
