Policy Analysis Statement:

Brief Description of Proposal -

Request authorization to accept grant funds from the FY 2017 Edward Byrne Memorial Justice Assistance Grant Program in the a mount of \$22,475 to be used as follows: \$6,100 to the Sheriff's Office for a speed board radar trailer; \$10,915 for the Dane County Drug Court Treatment Program; and \$5,460 for the Dane County District Attorney Crime Response Program. Funding of \$10,915 for the Drug Court Treatment Program and \$5,460 for the District Attorney's Crime Response Program are reflected in the 2018 Adopted Budget. The City of Madison will administer the grant funds.

Current Policy or Practice -

Acceptance of grant funds requires County Board approval.

Impact of Adopting Proposal -

Radar speed signs, also known as driver feedback signs, are traffic calming devices designed to slow speeders down by alerting them of their speed. A speed board radar trailer is required to transport the Sheriff's Office speed board radars to various locations where a speed reminder is necessary and adequate to slow down motorists.
