AUTHORIZING AN AGREEMENT TO ACCEPT HIGHWAY SAFETY GRANT FUNDS FOR AN ANTI-TEXTING/INATTENTIVE DRIVING ENFORCEMENT CAMPAIGN GRANT NUMBER FG-2015-DANE CO-02851

Policy Analysis Statement:

Brief Description of Proposal -

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is making funds available for participation in a 2015 Anti-Texting/Inattentive Driving Enforcement Project, Grant Number FG-2015-DANE CO-02851. The goal of the federally funded driving enforcement project is to decrease the number of person's texting while driving and ultimately reduce traffic crashes.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

With advancements in cell phone technology, distracted driving has been an increasing trend. Recent findings from the Nation Safety Council indicate the three greatest causes of fatalities on the road include alcohol (30.8%), speeding (30%), and distracted driving (26%). Implementing a law enforcement campaign to stop texting and driving will decrease injury and loss of life on Dane County roadways.
