ROOF CITY COUNTY BUILDING

*Amanda DePagter spoke in support of the proposal and answered questions.*

*Subcommittee members asked the following questions:*

- 1) What shape are the roofs in? A: They are currently in decent shape and down the road, by the time they need replacing, the project would have lasted long enough to have yielded results. The living roof might even prolong the current roofs' lives.*
- 2) Has there been a structural analysis to make sure the roofs can handle the additional weight of the living roof? A: Yes, Kurt Straus conducted the analysis and found that the current roofs can bear the weight of the living roof system.*
- 3) Will the roofs need maintenance? A: Not much. The plants used will be sedums. They will need no mowing, no watering, they will be selected for varied seasonal bloom times. If any maintenance is needed, there is direct and easy access to these roofs from the 2nd floor.*

### STAFF UPDATE ON ADDITIONAL 2019 SUSTAINABILITY EFFORTS IN COUNTY

*Lisa MacKinnon gave a brief update to let the subcommittee know that she is working with Amanda DePagter and Keith Reopelle on a RFP to contract for an Integrated Energy Master Plan for all county government facilities. It would be a phased approach and we anticipate that some of the later project phases could be included in the 2020 budget. We also anticipate that capital improvement recommendations that come out of this multiphase project could be funded both through the SMART Fund as well as through future county budget requests.*

*Chuck Erickson mentioned that he, Supervisor Miles, and Lisa MacKinnon would be meeting with Lt. Governor Mandela Barnes' office later this week to discuss county sustainability initiatives, plans, and projects and to get an understanding of how the state and county might work together to support our energy, climate, and sustainability efforts.*
