1. Drafting a Letter to Dane County Legislature Regarding Future of the ADRC's and ADRC Boards.

Frazier stated in the Governor's Budget there are major changes related to long term care including ADRCs as a part of that. He proposed that a letter be sent to all Dane County Legislators expressing concerns about the proposals and asking legislators to maintain ADRCs and related programs as they exist. He provided a draft of a letter he had prepared. The Board shared their ideas on what they felt the letter should include. The letter would contain concerns about the Governor's proposal to eliminate ADRC Governing Boards, Long Term Care advisory Councils and allow the State to contract with private entity to provide some or all of the services not being provided by ADRCs.

Along with the letter being sent to our Legistators, copies will be sent to the Joint Finance Committee, other ADRCs, Dane County Board of Supervisors, Dane County Executive Joe Parisi, Dane County Department of Human Services Director Lynn Green and Governor Scott Walker.

We are assisting people that lose their Medicaid eligiblity to get it back so they can reenroll into the program.
