AUTHORIZING ACCEPTANCE OF A GRANT FROM THE WI DEPARTMENT OF JUSTICE FOR FIELD TRAINING OFFICER (FTO) SEMINAR

The Wisconsin Department of Justice, Training and Standards Bureau, is providing grant funding for specialized career development training for Wisconsin law enforcement, Grant# 15-002. This training is offered in partnership with the Dane County Sheriff's Office and Kaminsky, Sullenberger and Associates, Inc., and will be held at the Dane County Law Enforcement Training Center, 9/29/2014 – 10/3/2014. The Wisconsin Department of Justice is providing up to \$8,855 to the Sheriff's Office to host the career development FTO training. BE IT FURTHER RESOLVED that up to \$8,855 is transferred from the General Fund to Sheriff's Office Firearms Training Center Hosted Training Course Expense Account (SHRFTC 21155); and

BE IT FINALLY RESOLVED that all unexpended funds and unrecognized revenue from this account is carried forward from the 2014 budget to the 2015 budget period.
