Recommend to the County Board denial of any and all plan changes to health insurance for the remainder of the current three year contract and if cost savings are required from County employees in the interim, implement other approaches which do the least collective harm to County employees such as voluntary time away, early retirement initiatives and, as a last resort, furloughs. Finally, create an Insurance Advisory Committee (IAC) Request for Proposals (RFP) Subcommittee to review and revise the RFP process for health insurance ahead of early 2027 when the County could next solicit bids for insurance so the employee representatives have a meaningful voice in any plan design changes.
