ADDENDUM A TO AGREEMENT FOR OPERATION OF THE DANE COUNTY
CONSTRUCTION & DEMOLITION RECYCLING FACILITY

Dane County owns and operates the Dane County Construction and Demolition Recycling Facility (the "Facility"), which recovers construction and demolition ("C&D") materials and supports the County's waste diversion goals; and

WHEREAS, the County and Pellitteri Waste Systems wish to construct and install several new safety systems at the Facility, including a catwalk, additional emergency stops, and conveyor spill point protections at an additional cost not to exceed \$230,000.00; and

WHEREAS, the County believes Pellitteri Waste Systems to be capable of installing and managing the construction of these safety systems; and

WHEREAS, Pellitteri Waste Systems is willing to perform the work and be reimbursed by the County upon completion and submission of documented expenses; and

NOW, THEREFORE BE IT RESOLVED that the County Executive and the County Clerk be authorized and directed to sign Addendum A to the Agreement; and,

BE IT FINALLY RESOLVED that the Department of Waste + Renewables be directed to ensure complete performance of the Agreement.

ADDENDUM #16425A

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and Pellitteri Waste Systems, Inc. (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract #16425A, have previously entered into a contractual relationship pursuant to which Provider operates the Dane County Construction & Demolition Recycling Facility (hereinafter, "Facility"), and

WHEREAS County and Provider wish to amend the Master Agreement in order to increase the 2026 Purchase Order for the installation of a catwalk, additional emergency stops, and equipment skirting to improve safety in the Facility.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. Increase the 2026 Purchase Order by \$230,000 (not to exceed). Funds will be distributed upon completion of work and documented receipts.
