PLEASE TAKE NOTICE that the Town Board of the Town of Roxbury, Dane County, Wisconsin, will hold four public hearings on the proposed adoption of the resolutions herein described. The public hearings will take place on January 6, 2025, in the order listed above with the first hearing starting at 7:00 p.m. or as soon thereafter as the Town Board may hear the matter and each subsequent public hearing commencing as soon as the prior hearing concludes, in the Roxbury Town Hall, located at 7167 Kippley Road, Roxbury, Wisconsin.

Said resolutions respectively propose the discontinuance and vacation of a portion of Ballweg Drive and all of Endres Drive, Haas Drive, and Kruchten Drive, as each is described below, pursuant to Wis. Stat. secs. 82.10-82.12. A preliminary resolution to this effect for each town highway was adopted at a Town Board meeting held December 2, 2024.

Final resolutions to vacate and discontinue a portion of Ballweg Drive and all of Endres Drive, Haas Drive, and Kruchten Road will be considered and acted upon at a regular Town Board meeting held on January 6, 2025, at 7:00 p.m.

<u>Ballweg Drive</u>: The portion of Ballweg Drive which is the subject of the first hearing and resolution is depicted on the plat or map attached hereto as *Exhibit A1* and more particularly described as follows:






